Eoi are invited for Empanelment of Training Partners for conducting Recognition of Prior Learning (RPL) activity for the Jal Jeevan Mission, Maharashtra Skill Development Scheme.

The Water Management and Plumbing Skill Council (WMPSC) has been awarded work order for imparting training and certification under Jal Jeevan Mission scheme in the state of Maharashtra.

The Response to EOI is invited for this scheme under following conditions:

- 1) The Training Partner (TP) should be affiliated with MSSDS / NSDC/ WMPSC.
- 2) The Training Partner (TP) should have their **REGISTERED ADDRESS** in **Maharashtra** state only.
(Relevant Documents to be furnished and submitted in hard copies to WMPSC)
- 3) Project Type- Recognition of Prior Learning (RPL) Type 1- As per PMKVY 3.0 Guidelines
- 4) Training Partner needs to submit the training locations as per the district wise allocation by JJM& MSSDC.
- 5) Training Partner shall complete the training program within the duration agreed (12- Hours Training)
- 6) The Training Partner(s) to whom targets will be allocated by WMPSC will need to get themselves on boarded on MSSDS portal. This will be done only post TP affiliation, after due diligence by WMPSC.
- 7) Training Partner affiliated by WMPSC for this project, will need to ensure infrastructure, tools, equipment and materials availability for training and assessment of the candidates. The daily attendance of the candidates shall be arranged and updated on MSSDS Portal by attendance system approved by MSSDS.
